#### **Short CV**

Waltraud Martius studied business management at the university of Innsbruck. Since 1989 she operates as a franchise consultant for her own company "SYNCON International Franchise Consultants". Until now she advised more than 1.400 franchise projects and has sustainably strengthened her reputation as a trendsetter in the franchise business. Many subjects which firstly were tackled by Syncon meanwhile became part of the standard catalogue of the franchise economy.

Waltraud Martius is active co-founder of the "Austrian Franchise Association" (ÖFV) and since 1986 in the board of directors in an honorary capacity. The honorary presidency was granted to her in 2008 for life-time. Since 20 years she is a lecturer at universities and advanced colleges in the German-speaking world and has shared her experiences through countless speeches in Europe as well as in the USA, India and China. She is a co-editor of the book "Franchising – Die Königsklasse der Vertriebssysteme (Franchising – the royal distribution system)", which was published in 2003 and author of the book "Fairplay Franchising", which was published in 2024 as a fourth edition and co-editor of the book "Wissens- und Innovationsmanagement in der Franchisepraxis (Practical knowledge and innovation management for franchising)", published 2015, co-editor of "Erfolgreiche Rekrutierung von Franchisenehmern (Successful recruitment of franchisees)" published 2018. In 2011 she was elected as a senator of the "Economic Senate" and works as a Pro Bono-Expert for ASHOKA International. In 2013 she joined the international Ashoka Support Network (ASN).
